**2024 Seasonal agreement**

Dear Friends and Campers,

The end of another season is drawing near. As always, each of you will have first choice of your current site for next year. If you would like to change sites please let us know immediately. Seasonal sites are permitted **one** camping unit per site without incurring additional charges.

If you are NOT returning for the 2024 season **please notify us prior to Oct. 1, 2023**, so we may discuss arrangements for removal of your trailer. The site must be vacated by October 17<sup>th</sup> or daily site fees will apply.

For 2024 our “summer” season will begin April 26<sup>th</sup> and will end on October 20<sup>th</sup>.

**Firewood ordered after 3/1/24 will take a minimum month to process, and we cannot guarantee delivery during the 2024 season.**

While non-seasonal sites are limited to no more than six (6) people, seasonal campers are permitted a maximum of eight (8) persons on the site, including yourselves and visitors, without having to rent another site.

**\*\*IMPORTANT NOTICE\*\***

If balance is not paid in full by April 1, 2024, \$400 late payment fee will be added to the account. Accounts that remain delinquent will be incur a finance charge of 2% per month (24% annually) beginning on May 1st, 2024. If not paid in full by June 1, 2024, **admittance to the campground will be prohibited until all fees are paid.** **If the site balance is not paid by August 26<sup>th</sup>, 2024, the trailer will be removed from the site and reported to and impounded by the police as an abandoned vehicle. You will owe the monthly site rate for the three months as well as a \$2500 site clearing fee.** Delinquent accounts are held responsible for any and all additional fees and collection costs incurred to secure payment (including cost of certified letters, attorney and collection agency fees, court costs etc.). The owner of the campground facility has a lien on all personal property located at this facility for rent, labor, or other reasonable charges due in accordance with rent of the campsite, but not limited to expenses incurred in any sale. You may charge your seasonal campsite fees on your major credit card at any time; however, you would not be eligible for the early payment discount.

**If your camper has occupied a site after 10/15/23 and you decide to leave & vacate the site by 1/31/24, the non-refundable deposit and the per month winter site fee from 10/16/25 is still owed. If your camper is still on the site after Jan. 31, 2024, and you decide to leave & vacate the site before April 1, 2024, 1/3 of the seasonal rate and the per month winter site fee is still owed. If the site is vacated after April 1<sup>st</sup> but before April 26, 2024, 1/2 of the seasonal rate and the per month winter site fee is owed. If vacated after April 26, 2024, you are obligated to pay the full winter site fee and the full seasonal rate for the 2024 season.** You must phone ahead before removing your trailer from the site. There may be weather conditions such as ice, snow or mud that would prohibit removal at that time. **It is best to vacate before winter. THERE WILL BE NO REFUNDS FOR EARLY DEPARTURE, AND ADDITIONAL FEES MAY APPLY.** PAYMENTS ARE NOT TRANSFERRABLE. Camping units on site after Oct. 15, 2024, will only be permitted if the minimum non-refundable deposit and signed seasonal letter for the 2025 season has been received.

Camp Taylor Campground and the Taylor Family are not responsible for camping equipment or personal items left on the premises at any time. Be sure to consult your homeowner's insurance policy to verify that your camping equipment is covered when away from your home. If it is not, or if you would like additional coverage, contact us for information about companies providing coverage. Please consult the seasonal information sheet for additional rules and policies regarding your seasonal site.

I acknowledge the campground is a primitive outdoor facility without paved walkways, street lighting, etc. and have no expectation of remediation of such hazards. I will have members and guests on my site behave appropriately & follow the rules of the campground described above and the general campground rules that can be found on the map and website. I also understand the rates and payments required as described above. I understand this is a recreational facility and may not be used as a residence, and I may not receive mail or send children to school from this campground. I acknowledge my responsibility to vacate and clean up my site by end of the camping season unless I complete the agreement and pay the required deposit for the following year. Sites occupied after the end of the season without a completed agreement and deposit will be charged the daily site rate.

# SEASONAL CLOSE-OUT 2023

## **\*\*IF YOU PLAN TO TAKE A SEASONAL SITE NEXT YEAR\*\***

**A completed seasonal letter with the required minimum \$650.00 payment needs to be returned to us by Oct. 1st, 2023.** On October 1<sup>st</sup>, any site for which we have not received a signed letter with deposit will be offered to those on our waiting list for seasonal sites next year. **If we do not have a completed and signed letter with payment, the site must be vacated no later than Oct. 15th or daily site fees apply.**

**REMINDER:** You must be paid in full by Feb. 1, 2024 in order to receive free winter storage.

## **\*\*WINTERIZING\*\***

The fee for winterizing this year is \$95 per unit, which includes the antifreeze. **No one will go on the list to be winterized until payment is received. If ordered, or payment is received after Oct. 15th, the winterizing fee is \$100 and we do not guarantee it will be done before it freezes.** No trailer will be winterized after Oct. 26, 2023. We will notify you via e-mail when your unit is winterized. You may not cover your trailer until after it has been winterized. Please remember to leave access to all faucets and drains. Do not pour anything down drains after you have been winterized!

## **\*\*LAST PUMP-OUT FOR 2023\*\***

The last regular pump-out of the 2023 season will be on Monday, Oct 16th. ***There will be no additional pump-out after that week.***

---

## **\*\*WINTER CLEANUP 2023/2024\*\***

Please take a good long look at your campsite. **You may not wait until next spring to dispose of your old and broken items.** Before you close up, please pack away any loose items (lawn chairs, screen tents, ornaments, flowerpots, toys, etc.) Store them in your trailer, a Rubbermaid type shed, or bring them home for the winter. If we are winterizing your trailer, be sure all passageways and access to all faucets and drains are clear. All ropes, strings of lights, feeders, signs, etc., must be removed from trees. All screen rooms, tents, solar lights etc. must be down and stored away. **Please remove all coverings from your picnic table,** as moisture gets trapped under them over the winter and rots the wood. The last day of the 2023 season is Oct. 15th. **All loose items must be packed away by Oct. 15th or they will be thrown out and you will be billed for the time it takes us to clean up your site. Sites should be empty except for the camping unit and the one permitted Rubbermaid storage shed. All trailers must be unplugged from electric on Oct. 15th.** Be sure to have all perishable foods removed by then. If you are still at your site, off-season camping fees will apply.

## **\*\*OFF SEASON CAMPING\*\***

Off season camping is only available for the people registered as seasonals for the upcoming season. You may not bring any guests during the off season. You may not spend more than 3 consecutive days at any given time during the off season. If you decide to use your unit after the season has ended, **you must notify us in advance and you must stop in and pay when you arrive.** There is no excuse for not paying when you are here. If no one is in the office or at the manager's house, please put your fee in an envelope and slip it under the office door. Please write your name and what the payment is for on the envelope. We do not pick up garbage or recyclables during the off season. Please bring them to the dumpster before leaving or take it home with you.

### **The fee for off-season camping is:**

\$9.00 per night electric

\$10.00 for each adult per night (age 17 and older)

\$3.50 for each child per night (age 2-16)

The water system to all sites will be turned off and winterized on Oct 23rd and will not get turned back on until April 19th. The restrooms (not the shower rooms) at the main office remain open year-round. As most of our electric maintenance and tree removal in the campground is done in the off season, there may be sections of the campground that are inaccessible or without power for extended periods of time. You must call us in advance of planning to camp in the off season to check the status of the electric and access to the site.

## **Request for Winterizing**

If you would like to have your RV winterized by us, this form with the \$95 payment must be received by October 15<sup>th</sup>. Clayton will start winterizing trailers the week of October 16<sup>th</sup> and no trailer will be winterized after Oct. 27<sup>th</sup>, 2023. If this form & payment is not received by Oct 15<sup>th</sup>, we cannot guarantee you will be winterized before it freezes. Your name will go on the winterizing list only after payment is received. If you are done using your trailer before the season is over and want to be winterized earlier than the week of the 16<sup>th</sup> please notify us.

Be sure we have all keys to access your trailer and compartments needed for winterizing.

**ABSOLUTELY NO ONE IS PERMITTED ON THE CAMPGROUND DURING THE SIX DAY FIREARM HUNTING SEASON FROM 6 PM DEC. 3rd THROUGH 8AM DEC. 10th. NO EXCEPTIONS.**

**IF YOUR TRAILER IS FOR SALE, PLEASE NOTE:**

You may not put a "for sale" sign on your trailer while it is on your site. You may post it on our bulletin board by the office. Site balances must be paid in full before a trailer is removed from the premises.

If you are not returning next season, you must notify us by Oct.1, 2023 and your site must be cleared by Oct. 15, 2023. **All trailers that are for sale must be off the premises by the end of the season (Oct. 15th, 2023).** Check with your local RV dealer to have your unit removed and sold. The best chance you have of selling a trailer is to put it on an RV dealer's lot.

**PLEASE DO NOT DELAY IN MAKING ARRANGEMENTS TO VACATE YOUR SITE IF YOU ARE NOT RETURNING NEXT SEASON.** If you vacate your site after Oct. 15th but before Feb. 1, 2024, you will lose/owe the \$650.00 non-refundable deposit that is due by Oct. 1, 2023 in addition to a \$100/month winter site fee. If your camper is occupying a site after January 31, 2024, and you vacate before April 1, 2024, 1/3 of the seasonal site rate and \$100 per month winter site fee is still owed. If you vacate after March 31, 2023 but before April 19th, half of the seasonal site rate and \$100 per month winter site fee is owed. If you vacate after April 19th, 2024, YOU ARE OBLIGATED TO THE FULL \$600 WINTER SITE FEE PLUS THE FULL 2024 SEASONAL SITE FEES.

**If we have to remove your unit and clear the site due to a delinquent account, there will be a \$2500 site clearing fee added to your bill and the trailer will be impounded by the state police as an abandoned vehicle. We are not responsible for any damage to the unit or items inside that may occur if we have to remove your trailer.**

If you have any doubts that your circumstances may allow you to return for the 2024 season, we strongly advise clearing your site before Oct. 16, 2023. Weather and ground conditions may prohibit access to sites in the winter and early spring, which could result in a substantial cost to you. If circumstances should change, you could always bring the unit back in the spring.

**2024 FREE CLEAN-UP WEEKEND is April 19<sup>th</sup> to the 22<sup>nd</sup> ONLY.**

We will allow any seasonal who would like to get a jump start on the new season to come up and de-winterize and do spring cleaning on their site free of charge. These are the only two nights from Oct. 15<sup>th</sup>, 2023 to April 26<sup>th</sup> 2024 that off-season camping fees do not apply. You may plug in electric while here, but trailers must be disconnected on the 21st. During the week of April 22<sup>nd</sup> to the 26<sup>th</sup> we be receiving our preseason inspections and scheduling final tree service so we can not have anyone in the campground from that Monday until that Friday. Do not leave perishables in freezer or refrigerator as electric may be off for periods of time between April 21st through April 26th, 2024. Starting on April 26<sup>th</sup>, trailers may remain plugged in while you are not here.

Please sign and return one copy of seasonal letter and seasonal reminders to the office, along with your required non-refundable \$650.00 deposit for the 2024 season before October 1<sup>st</sup>, 2023. **We do have a waiting list of people looking for sites so if we do not have your deposit and letter by October 1<sup>st</sup> your site may not be available next year.**
